## **Terms And Conditions**

A non-refundable deposit fee is required at the time booking.

The full balance of the intensive driving course in cash or bank transfer.

No driving courses will be brought over to the next week, unless agreed by the instructor. The total sessions of the course booked, includes the time for the test and dropped back home.

Extra sessions can be booked, but for an additional cost directly with your instructor.

If your instructor feels you are not ready to take your practical driving test, even on the day of your exam, because of safety to yourself, the examiner and other road users, then the pupil will NOT be allowed to take the Practical driving test with Drivingintensivelastminute.com.

NO refund for your practical driving test or driving course will be offered to you.

Pupils who NO-SHOW or cancel at short notice, for any of the tests or course lessons, will not be given a refund. We will then have the right to cancel the driving intensive course completely.

If the DVLA cancels a practical driving test on the day of the test then the fee for the instructor's time will still apply.

If a pupil cancels a driving course through their own decision No refund will be given.

If a pupil tests positive for Covid 19 or has any illness no refund will be given.

Pupils who book extra driving lessons and who NO SHOW or cancel at very short notice, less than 48 hours, then the missed driving tuition fee will be charged and payable to the driving instructor.

You must attend each driving session on time, and in a fit state to drive.

NOT to be under the influence of alcohol or drugs, including prescribed medicines that affect your ability to drive, as this will affect your concentration and awareness. If any of our driving instructors believe you are unfit to drive, he or she will tell you that the driving session/driving course is CANCELED because of legal reasons. No refund will be offered.

We will provide the pupil with the same driving instructor each day of the driving course unless circumstances arise. You will drive the same car unless, mechanically, the car breaks down and a hired due is given. This is no fault of the driving instructor and all attempts to provide a car for practical tuition will be attempted.

All attempts will be made to obtain a practical driving test on the last day of the intensive course if the pupil passed the theory test. Where this is NOT possible in securing a place, the pupil will be required to return later, to take their driving test. A day will be held back from the driving course for the day of the Practical driving test.

No practical test can be booked until the theory test is passed. A practical Driving test can only be achieved by the availability, when we consult the DSA website at the time of the practical test booking. Throughout the intensive course, The pupil will be assessed on their driving ability towards the end of the course practical mock tests will be performed. This allows an evaluation of the standard of driving. If it is thought that a pupil will not pass their practical driving test, he/she will be informed and if the instructor can accommodate, then the pupil will be offered extra lessons at the instructor's hourly rate, paid directly to the instructor.

A professional approach is demanded of the pupil and no abusive behaviour towards our instructor will be accepted. The intensive course will be terminated, and the fee for the entire course will not be refunded in such an event.

A driving course, any test fees and deposit will be held for a maximum of 3 calendar months, if the pupil is unable to start or complete the course for whatever reason after that time, a new deposit, test fees and driving course fees will be required to be repaid.

All courses are based on average learning capabilities and are only a guide. No guarantee of a 1st pass can be implied.

The contract of the driving course is between the pupil and the instructor. Any disputes, claims, or discussion should therefore be taken up with the instructor and not with us.

We cannot be held liable for any compensation claim from a pupil, nor can it be held responsible for any traffic law violation on the part of the pupil.

You must pass the legal eyesight test before being allowed on the course. The instructor will check this on the first lesson, if you fail a refund for the entire course will not be given. Therefore if you are in doubt, then please have your eyesight checked with an optician, in advance of your driving course.

We will use your personal data in accordance with the data protection act 1998 and it will be used to book your theory or driving test, to arrange your driving instructor regarding the course lessons and to take payment if necessary. We will only give your personal details to parties where the law either requires it allows us to do so.
